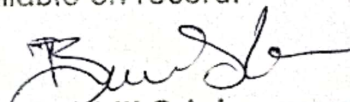

Sub: Hon'ble High Court of Telangana – WP.No.12851/2026 –
Ordered Notice - Personal Notice Permitted- Regarding.

1. You are hereby informed that WP/12851/2026 has been filed by my client, N.Satyanarayana H&T Contractors, at 3-2-56/5/4, Rajeev Gunj, Khammam, Rep.by its Managing Partner Sri N.Satyanarayana, seeking to set aside the Memo bearing Lr.No.MKTG/ Paddy/Tenders/ KMS 2026-24 dt.4.4.2026 issued by the 2nd Respondent rejecting Petitioner's technical bid submitted for Sector-III of Khammam District pursuant to Re-Tender Form dt.13.3.2026; and also declaring the action of the Respondents in qualifying your technical though you failed to submit Partnership Registration Certificate, which is a mandatory eligibility document, going to the root of bidder identity, and taking steps to appoint you (5th Respondent) as Paddy & Gunny Transport Contractor for the said Sector as illegal and unconstitutional, apart from seeking consequential reliefs.
2. By an interim order dt.24.04.2026, the Hon'ble High Court directed the Respondents not to finalise the tender for Sector-III of Khammam District pursuant to Re-Tender Form dt.13.3.2026. Later, by interim order dt.05.05.2026, the Hon'ble High Court extended the said interim order till 30.06.2026 and ordered notice to you and permit me to serve personal notice while directing to list WP/12851/2026 on 15.06.2026.
3. Therefore, in compliance with the directions of the Hon'ble High Court, I hereby issue this personal notice informing you that WP/12851/2026 will be listed before the Hon'ble High Court on 15.6.2026, and you are required to appear before the Hon'ble High Court either in person or through your Counsel as and when the said Writ Petition is listed. Failing such appearance, WP/12851/2026 may be decided in your absence based on the material available on record.
